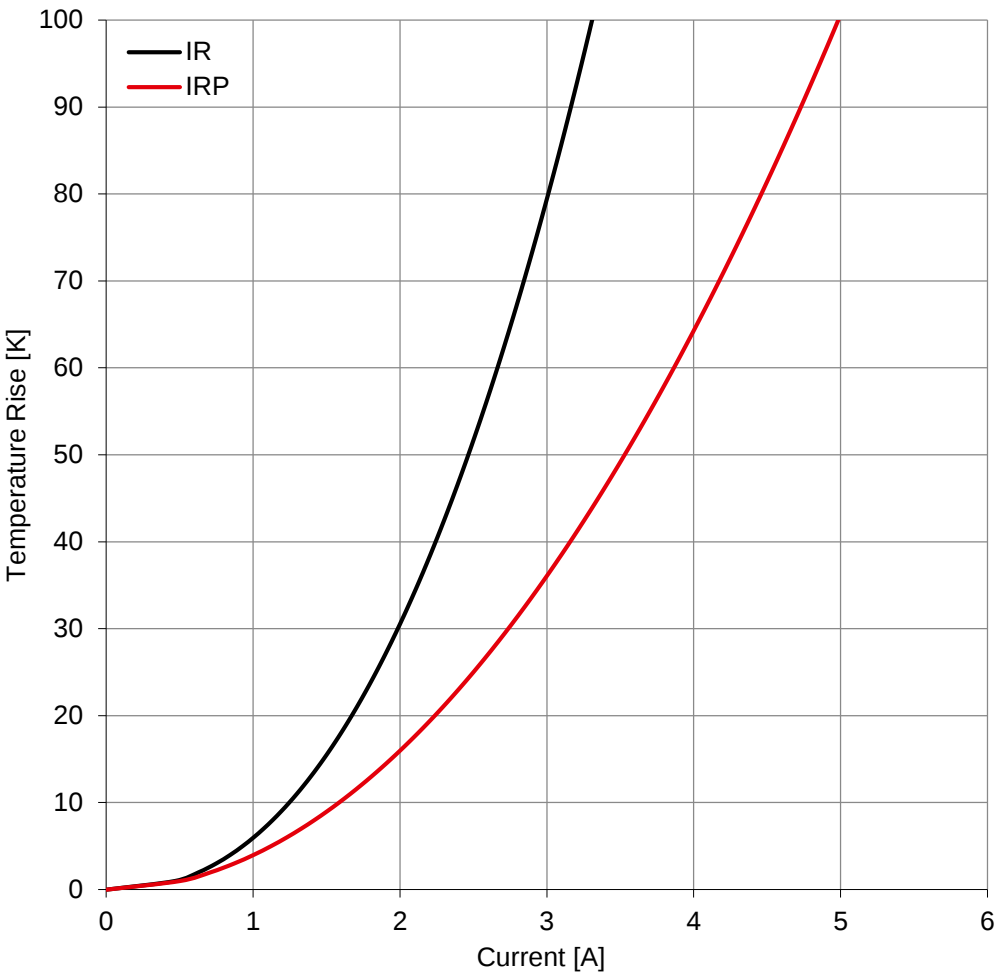

Typical Inductance vs. Current Characteristics:



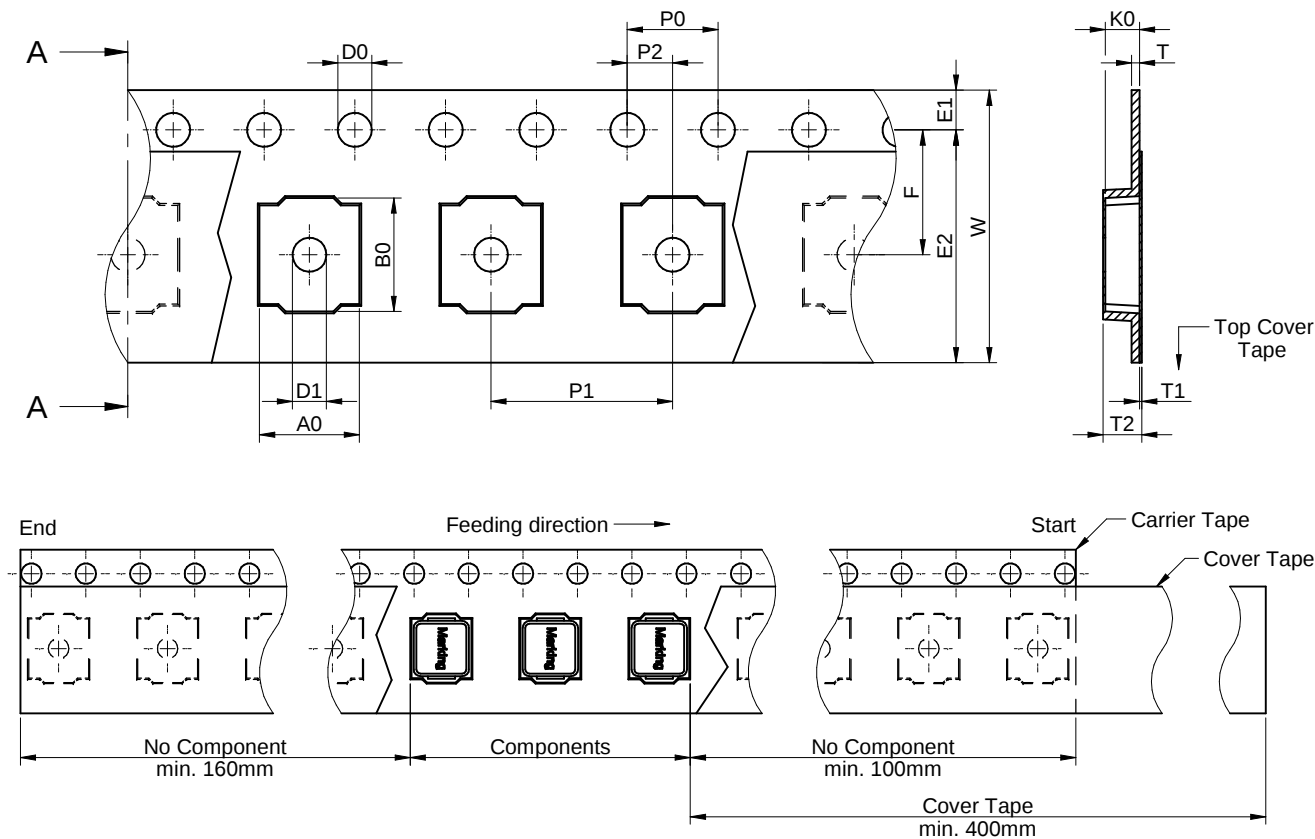
Typical Temperature Rise vs. Current Characteristics:



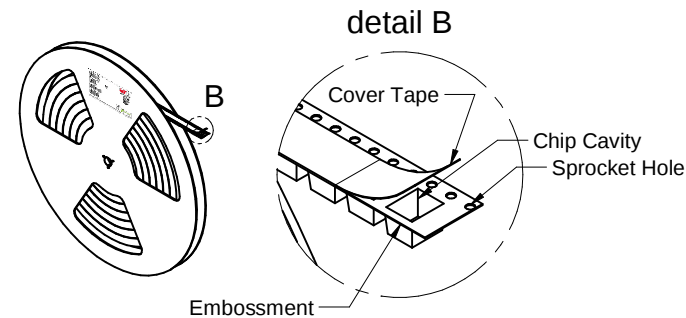
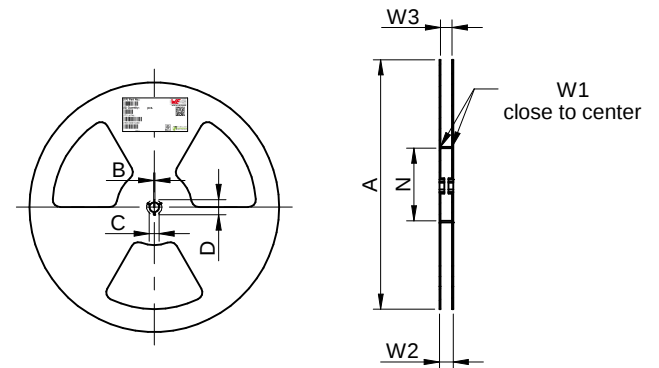

### Soldering:

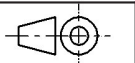

The basic responsibility of the customer as per Section 1 and 2 remains unaffected.

As a standard reporting procedure of the Product Termination Notification (PTN) according to the JEDEC-Standard we will inform at an early stage about inevitable product discontinuance.
